**A maximum of \$2500 is available for a property which could include one of the following:**

- **\$2500** - for projects that protect remnant indigenous vegetation through erecting fencing to permanently exclude stock, including around dams
- **\$1500** - for environmental weed control within good quality remnant vegetation or control of high threat weeds
- **\$1200** - for projects involving revegetation, fencing around revegetation and nestboxes, and

### Fencing projects

- Select if your project is **either** for fencing remnant vegetation or for fencing revegetation works- **not both**.
- Fencing of remnant vegetation and farm dams is funded at a rate of **\$20/m** up to a maximum of **\$2,500** (i.e. 125 metres of fencing)
- Fencing of revegetation works is funded at a rate of **\$15/m** up to a maximum of **\$1,500** (i.e. 100 metres of fencing)
- Any remaining fencing cost will be the applicant's contribution.

### Revegetation Projects

- Plants are funded at a rate of \$4 per plant (including stake/guard) up to a maximum of \$1200.
- Indicate the number of plants up to a **maximum of 300**.
- Site preparation, planting and maintenance will be the applicant's contribution.

### Nest box projects

- Nest boxes are funded at a rate of \$80 each up to a maximum of \$1200.
- Indicate the number of nestboxes up to a **maximum of 15**
- Installing the nestboxes will be the applicant's contribution

### Environmental Weed Control Projects

- Projects will only be funded where the works are in areas of good quality remnant vegetation and/or control of high threat weeds
- Control of City of Whittlesea Prescribed Pest Plants or noxious weeds **will not** be funded
- Control of pasture weeds such as Capeweed will not be funded
- Council will fund up to a maximum of \$1500, with the applicant required to match Council's contribution either cash or in-kind labour
- A suitably qualified contractor **must** be engaged to undertake the works
