The Zero Waste Rebate program is an action item in the [Rethinking Waste Plan 2021-2030 - Whittlesea](#), which outlines our goal to transition to a low waste city. It is one of several action items that will support our community to become leaders in clean, sustainable living. As part of the rebate program, residents will be able to claim a rebate on the purchase price of reusable nappies, reusable sanitary products, composting materials and collapsible shopping carts.
